:: GENERAL INFORMATION ::

Limit activity & interaction with others

Maintain public social distancing

Practice good hygiene & sanitization

:: GUIDELINES FOR RESIDENTS ::

- Citizens who feel sick should stay home
- Wash your hands and/or use hand sanitizer frequently
- Avoid touching your face
- Sneeze and cough into your elbow or a tissue.
- Avoid socializing in groups that do not adhere to social distancing guidelines.
- Minimize travel.
- Wear masks when in public or in close contact with others.

:: ADDITIONAL COMMUNITY INFORMATION ::

Shoppers are encouraged to limit to one person per household to limit store congestion.

Parks & Recreation:

- High traffic areas, such as playgrounds, will remain closed through May 31, 2020.
- Summer activities may commence but modifications should be considered to mitigate risk.

Large events or entertainment:

- Allowable with seating that meets social distancing requirements.
- This is applicable to movie theaters, stadiums, concerts, attractions, amusement parks, funerals, weddings, graduations and museums.

Churches may hold in-person services but social distancing requirements must be followed. Communal activities such as hand shaking and shared communion cups should be avoided. Churches are encouraged to continue to stream services as well.

Fraternal Organizations may gather but must adhere to social distancing standards.

:: GUIDELINES FOR BUSINESSES ::

Implement basic prevention measures including but not limited to:

- Personal protective equipment for employees & customers/clients where applicable
- Temperature checks & further monitoring of your workforce for indicative symptoms
- Sanitation and disinfecting common and high traffic areas (entrances, breakrooms, bathrooms)
- Have hand sanitizer available near the entrance for patrons to use upon entering and exiting the business.
- Modify workspaces to maximize social distancing
- Minimize business travel
- Offer workplace flexibilities (telework, work in phases or split shifts)
- Limit access of common areas where employees congregate
- Ensure a flexible sick leave policy

Occupancy Requirements for Business:

- Businesses with less than 10,000 sq ft must maintain 25% or less of the authorized occupancy.
 - Businesses with more than 10,000 sq ft must maintain 10% or less of the authorized occupancy
- *Employees of the workplace and vendors delivering product are not included in the occupancy.

If your business operates on appointments or reservations, implement a system where clients/customers can wait in their vehicles until they are notified to enter the business. If this is not feasible, social distancing measures should be put in place in public waiting areas. Additionally, appointments/reservations should be pre-scheduled and spaced out to minimize interaction and accommodate sanitization efforts.

Social distancing requirements do not apply to individuals performing job duties that require contact with other people closer than six feet.

Restaurants may reopen dine-in options but must implement regulations on self-serve options. Also, restaurants are encouraged to use disposable menus & wrapped straws and issue PPE to employees. Tables and seating (including barstools) should be spaced out according to social distance requirements. The continued use of drive-thru, carry out or delivery options is encouraged.
